



## Secure Access Control

In today's world of ever-evolving acts of terrorism, critical infrastructure, industries with sensitive data, schools and universities, and other organizations need to be increasingly vigilant in protecting their resources from an attack. Access control systems abound, but since Critical Infrastructure and Key Resources have no access to law enforcement data, no system provides sufficient information for threat assessment....until now. GREENLIGHT®, a public-private partnership, is the only solution today providing the power of law enforcement information to Critical Infrastructure and Key Resources. GREENLIGHT ensures data privacy by providing users a green or red signal, while simultaneously alerting law enforcement of potential threats.*

## How GREENLIGHT Works

Security professionals using GREENLIGHT can scan IDs or manually enter information of people, vehicles, and boats. GREENLIGHT then accesses federal National Crime Information Center (NCIC), state and local databases. Users receive a red light or green light signal, indicating whether there is a potential threat. If a red light signal is activated to the critical infrastructure facility, GREENLIGHT sends the red light "hit response" to a supporting law enforcement agency for immediate review. The law enforcement agency will then either take the appropriate action or "greenlight" the individual. GREENLIGHT also features a Person of Interest function.
